

## Provider Advisory Council

Value Behavioral Health of PA, Inc. (VBH-PA), in collaboration with our thirteen (13) HealthChoices counties, has a 26-member Provider Advisory Council comprised of two providers, one mental health provider and one drug & alcohol provider, nominated from each of the counties. Armstrong, Beaver, Butler, Cambria, Crawford, Fayette, Greene, Indiana, Lawrence, Mercer, Venango, Washington and Westmoreland counties are represented. As a body with equal representation from each county, the Council's mission is to focus on issues relevant to HealthChoices consumers and providers and to seek resolutions in an expeditious and effective manner. County Administrators and HealthChoices Oversight Entity Representatives, as well as VBH-PA Senior Management Staff, are also invited to participate in the Provider Advisory Council. Council Co-Chairs representing VBH-PA are the Chief Executive Officer and the Provider Relations Director. The Council Provider Co-Chairs are elected from the provider participants.

The Council determines the agenda items that they wish to consider. Examples are:

- The review and development of Policies and Procedures pertaining to provider network involvement;
- Provider Forums;
- Effective communication between VBH-PA and providers;
- Provider profiling;
- Claims processing efficiencies; and
- The role and responsibilities of Prevention, Education and Outreach (PE&O).
